Object: REACH application – Communication to our Customer concerning the application of Regulation EC No. 1907/2006

To the kind attention of your REACH responsible.

With the present document we would like to inform you that with reference to the Regulation EC No.1907/2006, our industrial activity shall be regarded as “Downstream user”, that means as user of substance, either on its own or in a preparation, bought from suppliers, that are (pre)registering or have registered substances and mixture in accordance with the above mentioned Regulation.

Therefore, our company shall neither be regarded as manufacturer nor as importer of substances and preparations extra EU (article 3 – regulation 1907/2006).

Within the area of our competence, the regulation is strictly observed, and it will be our duty to make sure that our suppliers, up in the supply chain, will fully observe every accomplishment regarding submission, authorization, arrangement for exposure scenarios and security schedules (articles 6, 31, 55 of the above mentioned Regulation).

We will also inform you that neither raw material nor preparations supplied to you are included into the restricted section foreseen by the article 67 and by the list in Annex XVII for substances/products whose placing on the market is strictly forbidden, also update candidate list of 27/06/2024,19/09/2024 ,07/11/2024, 21/01/2025 and 04/02/2026.
